GARGUNNOCK C.C. : A NEW BEGINNING OR THE BEGINNING OF THE END?

A SUMMARY OF 1995.

The twelfth season of the Club's existence perhaps marked a watershed in its history, as after only a few games, for which Saturday captain A. Williamson had struggled to raise a side, the Club was obliged to withdraw from the Perthshire League. After the departure, for various reasons, of Mike Hargreave, Norrie Jack and Gerald Dunkley, Gargunnock were always going to struggle, but with the older members of the Club preferring to play on Saturdays, no team of any sort, let alone a good one, could be fielded. This was a disappointing end to John Henderson's brave step in taking such a young Club into the league a few years previously.

The rest of the season therefore revolved around the Sunday and Wednesday teams, and during one period in May and June when five Sunday games in succession were called off due to the weather and the opposition's inability to raise a side, the only cricket available was on Wednesday nights. Thanks must go to Peter Sutherland for his efforts in organising the team, and it is to be hoped that he will do it all again in 1996, although Peter seems set on retirement after the nasty blow in the face which he received in the last game of the season against Inverclyde. In total twelve Wednesday games were played, and half were won, (which in Gargunnock terms must be cause for public celebration and dancing in the streets!)

Ten Sunday friendlies and two Cup games were also played, and two of these were won. It became clear during the season, (or even clearer!) that a number of the sides that we were playing (such as those with Australian professionals and others with giant Pakistani fast bowlers!) were way out of our league, and consequently it was a pointless exercise to play them. A radical rethink was clearly needed.

The AGM in October was well-attended (14 members plus the Chairman). At this meeting Martin Everett was elected Clubman of the Year, presumably for keeping the Sunday team going, and Graham Naris was elected Player of the Year, as he topped both the batting and bowling averages. Martin was re-elected as Sunday captain, and Andy Bryant became vice-captain. As John Henderson was about to depart for 3 months in New Zealand, Martin agreed to become Secretary, whilst David Fallow was elected Treasurer. Committee members are : A.Bryant, G.Gibson, W.McFadgen and G.Naris. A Grants' Sub-Committee (convenor G.Gibson) was also formed to investigate the possibility of grants from various sources for electricity, sight-screens, an artificial pitch and mains-drainage installation. Importantly, at this meeting, it was agreed that as there seemed little prospect of resurrecting Saturday cricket in the near future, the Club would apply to join the Strathclyde Sunday League.

Strathclyde Sunday League The AGM of this League was attended by Martin Everett on November 30th. Representatives from a number of clubs that we have played in the past were present, and it was gratifying to sense the enormous amount of goodwill that there is for Gargunnoch in cricketing circles. We were unanimously elected to the new Division Five (the lowest Division, obviously!) which has been formed by the amalgamation of the old Divisions Five and Six. Inverclyde, with whom we all (except Peter!) had a very enjoyable game at the end of the season, were also elected to this Division. The five other teams are : Ardrossan, Dunlop, Mirpur, (Glasgow), Cumbernauld, and Glasgow Airport. The standard should be such that we can compete reasonably, which will make a change! The downside to League membership is firstly the travelling, and secondly the fact that since there are now twelve League games, we have had to drop a certain number of our friendlies, but i have tried to keep the more enjoyable ones.

Friendlies and Cup Competitions : New friendlies have been arranged against Almond Valley, Kinross, Inellan, Comrie & West of Scotland. In addition we had the good fortune to be drawn against Bredalbane (Aberfeldy) in the Small Clubs' Cup, which will give us a good day out as well as a chance (perhaps!) of winning. In the Village Cup we have drawn the mighty Freuchie (complete with Scotland players?) at home, which should be an interesting experience! In my view we should not be looking to bring in imported "stars" for this game (are there any anyway?), but instead the people who turn out every Sunday, even in the less attractive away games, should have a chance to play in this attractive match. Let's hope that they bat first! The Strathclyde League also runs a cup competition, which takes place on Wednesday evenings, and we have been drawn away to Mirpur, who are an off-shoot of North Kelvinside.

The Annual Dinner : Despite the great amount of effort that Dave Fallow put into the organisation of this enjoyable event, only 5 members plus 4 ladies attended. Consequently the speaker had to be cancelled. This was obviously a very disappointing turn-out, though in fairness members were not notified of the date until a few weeks before the event. Perhaps next year an end-of-season dinner would be best, at the end of September? Steve Dolman has arranged for Bob Crampsie to speak for no fee, so it is to be hoped that we can get a reasonable turn-out of members in 1996.

The future ? In a way, the Dinner highlighted the situation now facing the Club : a lack of members and "life without John". By the time that Dave and I realised that we were meant to be organising the dinner, which wasn't clear until the AGM in October, it was almost too late. Everyone involved with the Club has been used to John doing virtually everything, but it is clear that now that he is involved with the County, we are going to have to take on much more ourselves. As far as membership goes, the Club could easily disappear unless we attract some new players. If we fail to field teams regularly in the Strathclyde League this season, it is hard to see how the Club can continue to play regular fixtures. Failure to fulfill our fixtures would

also mean a loss of the goodwill that the Club has built up over the last twelve years. Yet most of our players are in their 40s and 50s, and any young players will presumably gravitate to the County, where they will receive coaching and where there are youth teams, opportunities for development, etc. Doug. Smith has moved to the Isle of Man, Peter seems to have retired, Andy Bryant has started his own business and may not be regularly available; John has virtually given up playing....It seems that unless our small pool of players commits itself to playing every week, or unless we can attract some new members, then we will struggle in 1996. Perhaps if every existing member could introduce one friend or acquaintance...?

Dollar Nets : Dollar Academy, (and in particular the Rector, Mr. John Robertson), have very kindly agreed to allow us to use the indoor nets again in Jan./Feb./March. These sessions, at a cost of £2.00 per player, will begin on January 21st, and will run from 10.00 a.m. until 12.00 noon. It is again to be hoped that a reasonable number of members will come along, as much for the post-practice pint(s) as for the cricket! It should be noted that owing to a previous booking, there will be no nets on Sunday 18th February.

MINUTES OF ANNUAL GENERAL MEETING , OCTOBER 1996

PRESENT : E. Eccles; M.Everett; D.Fallow; G.Gibson; J.Henderson; G.Naris;

APOLOGIES : S.Dolman; R.Fuller; W.Scott; P.Sutherland.

MINUTES OF HALF-YEARLY MEETING , (17/4/96) : G.Gibson pointed out that he had not donated the match ball for the Freuchie Village Cup game, but had donated one later in the season. The accuracy of the minutes was proposed by G.Naris and seconded by D.Fallow.

CHAIRMAN'S REMARKS : John Henderson thanked all members of the Committee for helping to make the season a successful one. He commented on the Club's affiliation to Stirling County, and expressed the view that the arrangement had boosted Gargunnoch's playing strength, although it could possibly have financial disadvantages if County members did not also pay a Gargunnoch subscription. The chairman also remarked on the need for all members to assist with pavilion maintenance, and especially, cleaning. Additionally, the covers would require cleaning in the spring. Reports in the Stirling Observer had been missing during the 1996 season, and the Chairman hoped that this disappointing situation would be rectified in 1997. Mr. Scott had granted three dates to Stirling County during the 1997 season.

TREASURER'S REPORT : The Treasurer commented that the accounts had not yet been audited; the audited figures would be presented to the half-yearly meeting in April 1997. He thanked E. Eccles for his donation to the Club, and R.Fuller and D.Anderson for paying their subscriptions despite the fact that they were not required to do so under the affiliation arrangements. Income had been forthcoming from Subscriptions, Match Fees, the indoor nets at Dollar, and the Freuchie raffle. The Dinner had covered its own costs. J.Henderson explained the groundsman's expenses, and M.Everett referred to the Match Secretary's expenses. G.Naris had also incurred expenses for repairing the pavilion roof.

PAVILION IMPROVEMENTS : G.Naris reported on the work which he had carried out on roof during the season. If no further leaks appeared, the ceiling could be put back in position. Some painting was needed, and the step outside the visitors' dressing-room required repair.

Graham went on to outline his plans for the provision of showers and toilets in the pavilion. Plans had been presented to the Council, and if these were agreed, an application to the Lottery fund would be made. A total of £2,500- £3,000 would be required. This included the provision of a cesspool; the clay subsoil made a septic tank impractical.

If Council approval was forthcoming, a meeting would be sought with Mr. Scott to discuss the viability of the proposals.

C.Whaley added that a portacabin containing two toilets was currently being sold by the organisation for which he worked; it was roughly $\frac{3}{4}$ the size of the present pavilion.

J.Henderson suggested that this building could perhaps replace the existing collection of huts and sheds, and the score-box.

There was also some discussion of the provision of lighting, and of the need for a power supply for any showers that might be provided in the future. G.Naris commented that an electricity generator would be too expensive and too noisy. A 110v. system could provide enough power for lighting; it would cost over £300. Calor gas was another possibility to heat

water.

During further discussion on the subject of grants, C.Whaley suggested passing the lottery application to Stirling Sports Council for checking. J.Henderson remarked that a weakness of the club when applying for funds was the lack of a youth section and coaching facilities. C.Whaley also wondered whether the short lease would prejudice any application, but J.Henderson did not feel that it would. G.Naris explained that the Club would need to raise half of any sum required; at present funds stood at £1100 so there would be a shortfall. He was not in favour of increasing the sum applied for. The discussion on this subject was closed by J.Henderson suggesting that C.Whaley join the sub-committee that had previously been set up to explore the possibility of various sources of funding. He also expressed his thanks to Mr. K. Johnstone, architect, who had drawn up the plans for the proposed developments.

SECRETARY'S REPORT : M.Everett thanked Richard Turnbull, who had kindly produced a summary of the season's results, and the Club averages. He commented that the 1996 season had been the most successful ever in terms of matches won, due to the acquisition of several players from Stirling County and a realistic level of fixtures. The move into the Strathclyde League had been successful, and the Club had also reached the quarter-finals of the Small Clubs' Cup for the first time. On this subject, J.Henderson pointed out that the rules regarding player availability for the cup competitions should be strictly adhered to. M.Everett pointed out that there was a problem with keeping track of player eligibility unless the players concerned pointed out their situation themselves.

The Secretary went on to refer to the use of the nets at Dollar Academy during the winter. This had been successful, but there was a problem with the key, which had to be collected from Kippen; this was difficult unless M.E. attended every week. Outdoor nets at Meiklewood had not proved successful, and J.Henderson suggested practising on the square. M.Everett supported the idea of an artificial pitch and a net cage on wheels, as used at Helensburgh and other clubs.

Regarding the future election of Clubman and Player of the Year, the Secretary pointed out that the decision was more difficult now that the Dinner was held before the AGM. J.Henderson replied that the choice should be made by the committee in future.

On behalf of members, the Secretary thanked D.Fallow and S.Dolman for organising a very successful Dinner, and it was agreed to hold the 1997 Dinner in September. Discussion turned to the use of Meiklewood by other teams; J.Henderson stated that the GHK game would probably be played at Williamfield in future, owing to the costs incurred by himself under the present arrangement.

ELECTION OF OFFICE-BEARERS : The following were elected :

Chairman : Mr. W. Scott. (Proposed J.Henderson, seconded G.Naris).

Vice-Chairman : J.Henderson. (Proposed G.Gibson, seconded M.Everett).

Treasurer : C.Whaley. (Proposed J.Henderson, seconded M.Everett).

Secretary : M.Everett. (Proposed G.Gibson, seconded J.Henderson).

Captain : M.Everett.

Vice-Captain : G.Naris.

It was agreed that G.Naris would captain the side in half of the fixtures, and would be responsible for team organisation for these matches.

ANY OTHER BUSINESS : Subscriptions : It was agreed that the annual subscription would remain at £25.00 for senior members.

It was suggested that Stirling County members who played on a regular basis for Gargunnoch should be asked to pay a £10.00 affiliation fee, (after playing 5 games). This was to be raised by J.Henderson at the S.C. AGM.

Match-fees were to be increased to £2.50 for home matches. It was suggested that there should be an additional levy for beer for the opposition.

Match-fees for away games were increased to £3.00. Drivers were to be exempt.

Wednesday Fixtures : It was agreed that Gargunnoch would withdraw from the Stirling Evening League due to difficulties experienced in raising a team and to the unpleasant nature of some of the matches. Some friendlies, (e.g. Dollar, Kippen, Doune) would be arranged instead. A Wednesday captain/organiser was required.

Committee : In addition to the office-bearers, E.Eccles, W.Strange and D.Fallow were elected to the Committee .

Press Officers : G.Gibson and P.Sutherland agreed to serve as Press Officers and to be responsible for placing match-reports in the Stirling Observer.

Tour : A weekend at the Riverdale Hall Hotel in Northumberland was discussed. The Secretary was to explore costs, dates, etc.

Village Involvement. : D.Fallow commented on the need to involve the village in the Club. He suggested a Quik Cricket tournament for primary school pupils. J.Henderson suggested that due to the lack of interest in Gargunnoch itself, an amalgamation with Kippen might be desirable in the future.

GARGUNNOCK VILLAGE CRICKET CLUB WINTER NEWSLETTER

In terms of matches won, the 1996 season was the most successful in the Club's short history. Twenty-six games were played, (six of these were Wednesday fixtures), 13 were won, 12 lost and one was abandoned. This success was due mainly to two factors: a realistic fixture-list comprising friendlies and Strathclyde Sunday League Division Five games, and the acquisition of Stirling County "veterans" Roger Fuller and David Anderson, both of whom averaged over 30 with the bat; a novelty indeed for Gargunnock! Remarkably, the Club also reached the quarter-finals of the Small Clubs' Cup for the first time after three good victories, (although this was arguably one round too far). In the Strathclyde League we finished third out of seven teams :

GARGUNNOCK PROMOTED

At the League meeting in November, a combination of circumstances led to Gargunnock winning promotion to Division Four. Firstly, one team had dropped out of Division Three altogether, (Hillhead), and secondly, two teams in the existing Division Four have amalgamated, (Hyndland and Bishopbriggs). This meant that two teams instead of one were promoted from Division Four, and three teams instead of two were promoted from our Division. Additionally, a further five teams have joined the League, creating a new Division Six, so we find ourselves, in only our second season, in Division Four, with a Division Five and Six below us! (Of course, like the Small Clubs' Cup Quarter Final, this could prove to be a mixed blessing). The teams in our section will be our friends from this year Mirpur, (now called East Renfrew), and Dunlop, plus Allan Glen's (the result of the Hyndland/Bishopbriggs merger), Kilmarnock, and Vale of Leven. This will obviously be a stiff section!

ANNUAL GENERAL MEETING

At the Club AGM in October, Martin was re-elected as Club captain, and Graham Naris was elected vice-captain. However, Martin and Graham will share the captaincy and team-organising duties for next season. Martin was also re-elected as Secretary/Match Secretary, and Chris Whaley was elected Treasurer in place of Dave Fallow, who did not wish to serve for another year.

Eddie Eccles, Billy Strange and Dave Fallow were elected to the committee, and George Gibson and Peter Sutherland were appointed Press Officers. It is hoped that regular match-reports will appear in the Stirling Observer next season.

The accounts showed a surplus of £1,146.97, and Graham outlined his proposals for the improvement of facilities in the pavilion. He had submitted plans to the Council requesting their permission to dig a cesspit, which would provide drainage for showers. (Unfortunately, since the AGM the Council have rejected these plans). There was also some discussion about the possibility of providing lighting for the changing-rooms, and about application to the Lottery Fund.

SUBSCRIPTIONS AND MATCH-FEES 1997

It was agreed at the AGM that the 1997 subscription should remain at £25.00. Home match-fees would be raised to £2.50 per game, and away match-fees would be £3.00, although drivers to away games would not have to pay this.

THANKS

Thanks were noted at the meeting to Richard Turnbull for his hard work in compiling the averages; to Dave Fallow and Steve Dolman for organising the very successful Dinner, to Graham for his work on the pavilion and of course to Mr Scott for his continuing support and for very kindly organising the painting of the pavilion. All Club members are also very grateful to John for all his work on the ground, and we should note John's comments that often the changing-rooms and lounge are being left in an untidy state in our desire to get to the pub! It is unfair of us to put the burden of cleaning on John.

DOLLAR NETS BEGIN JANUARY 1997

We are fortunate that we have been granted the use of the indoor nets at Dollar Academy once again, beginning on Sunday January 26th. It is expected that the nets will run for about 9 weeks. The cost will again be £2.00 per session, provided that we get at least 8 people per session to cover the cost.

FIXTURES 1997

This season we have 10 Sunday League fixtures. In addition we have been drawn away to Dunlop in the Village Cup and away to Rossie Priory in the Small Clubs' Cup. Friendlies have been arranged against Kinross, Doune, Inellan, Aberfeldy, Dollar, West of Scotland (at Hamilton Crescent) and Bute County, (at home!).

It was agreed at the AGM that because of difficulties in raising a Wednesday side, and also due to the unenjoyable nature of some of these games, Gargunock would not participate in the Stirling Wednesday League in 1997. However, games have been arranged with Clackmannan, and Dollar are hoping to organise a tournament spread throughout the summer involving Kippen, Doune, Gargunock and themselves, to be played on Wednesday evenings. It is hoped that members will try to support these games, as it would be a pity if Wednesday cricket ceased entirely.

NEW MEMBERS NEEDED

Some long-standing members are making threatening noises about not being available very often next season. (For instance, Richard Turnbull is at University in Edinburgh, and Dave Fallow is starting a business). We were fortunate at the end of last season to welcome Eddie Eccles and Billy Strange back into the fold, but clearly we could do with some new members. It seems unlikely, given that we are so close to Stirling County, that we will attract many youngsters.

CONGRATULATIONS CHRIS!

At the Strathclyde League Meeting in December, Chris. Whaley (or in fact Martin, in Chris's absence!) was presented with the trophy for the best bowler in Division Five. Chris took 19 wickets in League matches at 13.42. Surprisingly, despite a League batting average of 44.66, Roger Fuller did not win the Division Five batting award, which went instead to Richard Rutnager of Dunlop. Still, he did play First-Class cricket, whereas Roger only played once for Gloucestershire Seconds! Who would have thought that Division Five would boast two such exalted cricketers? (Plus, of course, David Anderson, ex Stirling County captain).

1997 "TOUR"

At the Club's AGM it was suggested that we try to organise a weekend at the Riverdale Hall Hotel, at Bellingham Northumberland. A few long-standing members may remember the Club's last visit there. The Hotel has its own ground, and arranges fixtures against local sides or other visiting teams. There are also opportunities for golf and fishing. Unfortunately the local club which uses the ground has not yet arranged its fixtures for 1997, so the Hotel is not sure when the ground is free for touring sides. I have had to arrange our own fixtures, and the only weekend now free would be at the end of September. However, this might make a good ending to the season. Prices are around £40.00 per night per person, but it is not clear whether this includes meals. Presumably we could either travel down on the Friday night and stay for two nights, or just travel on the Saturday morning. Either way we would play on Saturday on Sunday afternoons. If we are going to attempt this venture, we would obviously need a firm commitment from eleven or twelve people. (I.e. just about everyone!)
