KEY TO SYMBOLS

- A Completed course in Valladolid and were ordained in Spain.
- B Completed course in Valladolid but were ordained in Scotland.
- C Began course in Valladolid but (because transferred by bishop or dismissed by rector, or due to ill health) completed studies in another seminary and were then ordained.
- D Left in ill health and died soon after

leaving. (In addition, a few of those ordained died soon afterwards.)

- E Left because of ill health.
- F Expressly noted as dismissed.
- G Left of their own accord (or, in some cases, for unspecified reasons or because transferred to other seminaries, without being finally ordained).

SPANISH STUDENTS

From 1784, Spanish boys were admitted to the college for board and tuition, even although they had no wish to become priests. The following list is probably fairly complete for the period it covers.

In 1804, there were fourteen Spanish pupils in the college at the one time. Two years later there were twelve and, in 1822 or just earlier, there were seven. However, the names of those admitted from 1804 onwards are not available. The custom probably ceased soon after 1822.

ADMINISTRATORS OF THE COLLEGE PROPERTY IN MADRID

1. MARTIN JOSEPH DE ZARRA-
GOITIA
appointed by the government after
expulsion of the Jesuits; died, 7th
October 1772.
2. MIGUEL MATHIAS DE SOBRE-
VILLA
died, 1st September 1785.
3. GASPAR ANTONIO DE IRUEGAS
brother-in-law of no. 2;
died, July 1799.
4. MARIA TOMASA DE ORDOÑO
wife of no. 3;
demitted, 28th October 1799 (rector
having retracted offer of post).

From then until 1820, the adminis-
tration was in the hands of the firm
known as IRUEGAS Y SOBREVIL-
LA; from 1820 until the end of
January 1832, the administrators
were the firm IRUEGAS HERMA-
NOS. During these years, the indi-
viduals in charge were the following
three.
5. FRANCISCO ANTONIO DE
BRINGAS
died, 15th February 1822.
6. FRANCISCO DE BRINGAS E
IRUEGAS
son of no. 5;
demitted, 9th May 1831 (having
been imprisoned in March for liberal
political opinions).
7. MIGUEL DE SOBREVILLA E
IRUEGAS
son of no. 2 and ex-student of the
college (Spanish Students no. 4);
died, 28th January 1832.
8. DIEGO BREÑOSA
demitted, 26th June 1832 (rector
having terminated appointment).
9. JUAN DE GARAIGORTA Y LE-
CANDA
absconded, 10th June 1858.
10. MANUEL GARCIA MANSO
died, 12th April 1864.
11. MARIANO GARCIA MANSO
brother of no. 10;
died, 7th February 1887.
12. CRISTETA MENCIA
wife of no. 11;
demitted, 18th October 1917 (when
original Madrid property sold).
13. FEDERICO DE BLANCO Y PE-
REZ DE VERA
died, early 1927.
14. RAFAEL MUÑOZ Y LOPEZ
died, June 1941.
15. EMILIO LLASERA DIAZ
died, 29th May 1968.
16. MIGUEL ESQUER Y DE LA TO-
RRE
