

SSL Membership Virtual Meeting October 27, 2020

Mr. Wilson thanked all for attending our virtual meeting, which started at 7:15PM. Program Commissioner Robbin Goodin introduced our presenter, storyteller Mandy Dick. She is sharing Scottish Halloween tales with us tonight.

Mandy started with the story of The Great Eastern, as she said someone had asked for it in the past, but she could not remember his name. In the 19th century steamships were the ultimate in speed, reliability, and safety. In the early 19th century, an amazing engineer named Isenbard Kingdom Rummell designed many steamships. He designed the largest steamship of the

time, The Great Eastern. Many problems arose during the construction of the ship, and it took 6 years to build. It was a double-hulled ship, which was common at the time. During construction, several things happened to delay construction. A riveter and his apprentice disappeared. A search was made, but neither man was found. Workers began to hear strange noises from inside the hull, hammering and tapping, and on a still night screams and cries could be heard. Finally, another search was made, as the hull had not yet been sealed up. Again, nothing was found. But the noises continued.

When the ship was finally finished, the captain's launch capsized on the way to the ship, and he and two others were drowned. A crane accident killed 5 men and injured another, then a boiler explosion killed 6 more men. Finally finished, she was launched in 1859; she was equipped to carry 4000 passengers and 400 crew. On her first voyage she carried 43 passengers, far less than capacity, but people were put off by the ship's reputation for deadly accidents. When they reached New York, one of the ship's side wheels tore up the dock. The ship was too big for the available facilities to moor safely. After repairs, the ship returned to England. On the second voyage, there were 40 passengers. On arrival in New York, a gash was torn in the outer hull. Once again, the ship needed repairs before returning to England. One more passenger run was made, but people did not want to travel on such an ill-fated ship. It was converted to a merchant ship and used to haul freight.

When the Trans-Atlantic Cable was set to be laid, The Great Eastern was chosen to haul the 2200 feet of cable needed. The ship was large enough to carry all the needed cable. Halfway across, the cable broke. They were unable to find the cable to splice it together, and the ship went back to England. The ship was outfitted again with the needed cable in 1866, and this time was successful in laying the first trans-Atlantic cable from England to New York.

She continued in service as a merchant vessel for about 20 years. Eventually, the ship was retired and cut apart for salvage. It took 200 men working 7 days a week 2 years to finish the job. During the dismantling, two skeletons were discovered inside the double hull. The missing workers had been found and we hope they were given a decent burial.

Her second story was about Fyvie Castle, a fearsomelooking block of a castle which is the longest

continuously occupied castle in Argyll, Scotland, built in the early 1200's. About the 1400's, there was a very eccentric bard named Tanner the Rhymer who traveled about, taking the news and entertaining people. It was said that he could control the weather, and if he became angry, storm clouds quickly gathered and rain fell. If he were in a good mood, it was sunny and fair. He was held in great esteem by all, and people were careful not to anger him.

He let it be known that he wanted to visit Fyvie Castle, and the Laird had the door opened, and swore it would not close until after Tanner had come to visit. He was a little late. He did not go straight to the castle, but the doors were kept open for him all the same. It took him seven years to reach the castle, and the door was kept open all that time. But just as he reached the great door, a storm sprang up, not of his doing, and the door slammed shut in his face. He became enraged, and cursed the family for the insult, though it was not of their doing. He said the Laird of Fyvie would never be succeeded by his eldest son until three stones that had been one were reunited. One was at the bottom of a deep lake, one in the foundation of the castle, and one was in the wood that surrounds the castle. This stone was eventually found.

Since only one stone was ever found, the laird has never been succeeded by the eldest son. They have died in battle, from disease, or gone overseas and died before they can succeed their father. The one stone that was found was kept in a bowl in the castle, as it oozed water continually, requiring the bowl to be emptied daily.

A man named Thomas Seaton took control of Fyvie Castle and married a wealthy woman, Dame Lillias Drummond, who bore him four daughters. He was angry with his wife for not giving him a son and began to ignore her and treat her shabbily. He became enamored of a sixteen-year old girl, the daughter of a neighbor, and wanted to marry her, believing she could give him the sons he so desired. And so, he devised a scheme to rid himself of his wife. He let it be known that she was unwell and could receive no visitors. She died, and it is believed that he locked her up and let her starve to death. Immediately after her death, he married Griselda. On their wedding night, they had no rest in their sumptuous bedchamber, as there were sounds of loud moaning, groaning and scratching just outside their chamber window. This was impossible, as the window was very high up in the castle. A search was

made, but nothing was found. All returned to their beds, but the scratching and moaning continued all through the night. In the morning, the new bride opened her high window to find the former wife's name, D. Lillias Drummond, scratched into the stone of the windowsill in letters 3 inches high. Thomas Seaton did not live long after. And ever after, her ghost has been called the Green Lady of Fyvie Castle.

#### Next, The Piper of Duntroon

Duntroon Castle was occupied by an ambitious man named Colkita, of the Campbell clan, who went by Kita. He was six feet six inches tall, and a formidable sight in battle with his great Claymore. This was a time of unrest due to religious animosities. He was Catholic and fought for the King, who wanted to make Catholicism the religion for all. Kita took over the surrounding countryside, and believing his castle to be safe, he left it only lightly garrisoned while he took his army to conquer those who were not immediate neighbors. He also left his best piper behind in the safety of the castle, as he believed no one would harm a piper, as they were held in such high esteem.

Clan Malcolm attacked his castle in his absence, and quickly overwhelmed the small garrison. All the survivors were imprisoned except for the piper. He was allowed the run of the castle and was required to play every day as he had always done, to keep up the fiction that all was well at the castle.

When Kita's ships were sighted on his return, the piper went up on the wall and played. At first, the piping was the usual welcome home, but then the piping began to change to something that meant 'turn away'. Kita realized something was wrong and turned his ships away from the castle and escaped. As punishment, the piper's captors cut off his hands and let him bleed to death. For years after that, people heard a piper playing when none was there.

In 1888, restoration work turned up a complete skeleton in the courtyard, except for the hands, which were nowhere to be found. The skeleton was taken up and buried by the bishop himself with full honors as the castle's piper. But because he was buried with the Anglican rites, he is supposed to roam the castle, playing from time to time, as he cannot rest.

Cheri told us that there is a story about Tanner the Rhymer in her future presentation. Archie Cunningham

let us know that he was the one who had asked for the story of The Great Eastern.

After Mandy finished with her presentation, Mr. Wilson and the audience thanked her for the Scottish tales she shared with us. We really enjoyed them, and they were just right for Halloween.

Mr. Wilson asked for visitors, but there were none. Mark Johnson told us that his new book, Sherlock Holmes and the Werewolf of Edinburgh, Book 2 will be available on Amazon on November 10, and at Barnes & Noble soon. He will let us know if there are any book signings, though none are on the horizon at this time. He reminded us that he writes as M.J. Downing. Marla Jo suggested that John Moffett announce the book's release in the newsletter, which he said he would be glad to do. Mark will send him the information.

Mr. Wilson started our monthly virtual meeting by thanking all who had been able to come. He then asked for any old business. Seeing as there was none, he invited all to imbibe in their favorite beverage, and then went on to new business. He had received an email from Brigdet Letts about restaurants that will donate 15% to 20% of profits if our members eat there. He sent this to Robbin, who had not read it yet. He asked her to read it and let him know if she thinks this would be a good idea. She will get back to him later.

David Rummler said that he will put his name to be a Regional Celtic Commissioner.

Vice President Jim Hughes just had surgery, and Jean said there was no report.

Secretary Linda Wilson had nothing to report.

Treasurer Cheri Eskridge reported the account totals. The Heritage Fund has paid \$553 for three sets of lessons. John Dickson asked when the audit can be done. Jeff Forbes, John Dickson and Cheri are on the finance committee. Cheri said she will email John and Jeff, and they can arrange a date for the audit.

Membership Commissioner Marla Jo Cameron reported that we have 70 family members, 33 Life members, and 37 individual members, giving us a total of 140 members. We have several new members, which are reflected on the newest member roster.

Hospitality Commissioner Anne Lewis had no report.

Program Commissioner Robbin Goodin reported that nothing is going on at this time. Next year some things should be available. She will update in the newsletter as she gets new information, hopefully by the December newsletter.

John Moffett said the newsletter is almost done, and he just needs some reports from officers and a write-up on Mandy's stories to publish.

Member At Large Dianne Holland was not at the meeting, but Pat Schweitzer was able to attend. Mr. Wilson and Pat discussed the Facebook page, and he agreed that she could do this if it was all right with Archie. Pat called Archie Cunningham about the Scottish Society Facebook page. They discussed it, and Pat asked if she could take on this responsibility. Pat said that Archie was glad to let her do this. She will post something every day, so check out The Scottish Society of Louisville on Facebook and 'Like' it. She said to make sure to include 'The' in the name. Mr. Wilson thanked Archie for his service the past few years. There is no report for the Clan McFritz, and Pat told Mr. Wilson to please take Clan McFritz off the agenda until something starts happening again. She says she'll let him know when she has something to report.

John Moffett asked if anyone had heard how Melissa Ingram and the Celtic Pig food truck were doing. Mr. Wilson spoke to Melissa recently, and the food truck is in business, though the restaurant is still closed. John has heard of an opportunity for the food truck, and he will contact Melissa to let her know.

Mr. Wilson let members know that his father-in-law had fallen and broken his collar bone. He is in a sling and doing well, and no surgery was needed.

Electronic Commissioner Damien Burns explained that he will take pictures and videos from previous Burns' Night festivities and make a composite video which he wants to permanently post on the website. Please send him any pictures or videos you may have as soon as possible to give him time to put the video together. He wants to post it on the same day we would have had Burns' Night, January 30, 2021. He will post this memorial of past Burns' Nights on our website permanently, to give people an idea of the kinds of things that the Scottish Society does. This was in the newsletter last month and will be in this month as well.

Joan Hale suggested a goodie bag with shot glasses, little bottles of booze, and shortbread cookies. This was brought up at a prior meeting, and it was decided that it would be too difficult to deliver the bags and we dropped this idea.

Marla Jo pointed out that her flag was left out of the parade of flags last year on Burns' Night, and Mr. Wilson told her they will look for it when they get the flags out of storage at Strathmoor Church so it can be included in the video.

There were 31 members present for this meeting, a nice increase in attendance.

Mr. Wilson adjourned the meeting at 8:35PM.

Mandy the Storyteller started with a story about haunted ships. These ships were constructed in the early 1800s and told of stories of their construction and mishaps along the way. The Great Eastern Steam Ship was one that was believed to be cursed and haunted. The Great Eastern was built in 1859 and was almost 700 feet long, which was the largest ship of the day. It had a double steel hull and had 3 means of propulsion; 5 masts for sails, steam driven paddle wheels and a single screw, steam driven propeller. This ship had over 30 deaths associated with the commercial shipping.

It is safe to say that the Great Eastern developed a reputation that it was haunted. The ship was built to hold 4,000 passengers and 400 crew. Many of the trips had only 50—100 passengers, because of its haunted reputation. Click Below for more.






## Hummingbird Cake - Three layers

## Ingredients

- 3 Cups All-Purpose Flour
- 1 tsp Baking Soda
- 1 tsp Salt
- 2 Cups Sugar
- 1 tsp Cinnamon

Cream Cheese Frosting

- 3 large eggs beaten
- 1 Cup Vegetable Oil
- 1 1/2 tsp Vanilla
- 8 oz Crushed Pineapple with juice
- 1 Cup Chopped Pecans
- 2 Cups Chopped Bananas
- 1/2 Cup of Chopped Pecans



### **Directions**

- Combine first five ingredients (flour, baking soda, salt, sugar and cinnamon)
- ◆ Add eggs and oil and mix with dry ingredients just until moist. DO NOT BEAT.
- ♦ Stir in Vanilla, Pineapple with juice, 1 cup pecans and bananas.
- Pour the batter into 3 greased and floured 9" cake pans.
- Bake at 350° degrees for 25-30 minutes or until knife inserted comes out clean.
- ♦ Cool and ice layers with cream cheese icing.
- Garnish with remaining ½ cup of chopped pecans.
- ♦ Enjoy!

# **BEGINNER LEVEL**Dower Rights

Dower rights were a protection to a wife so she would not be left out of her husband's wealth after his death. Upon the death of a husband, a widow was entitled to one-third of her husband's estate, thus her dower rights (as a wife) became her dower share (as a widow), often referred to as the widow's third.

Dower was a widow's right to a lifetime interest in onethird of all land owned by her husband, unless she chose, in place of dower, to accept other property left to her under her husband's will. Generally, dower applied to each parcel of land in which the husband held an inheritable interest at any time during the marriage. In the United States, dower is found in the eastern and Midwestern states where law was derived from the common law of England.

Researchers must determine the legal implications in effect at the time of the dower to form a hypothesis or a conclusion from the presence or absence of a wife or mother's mention in a deed, will, or intestate land distribution. If you locate a deed from a married man which his wife had not joined in making, does it mean that she had already died? In most American colonies and their successor states, a surviving wife who had not joined in the deed could sue the purchaser after her husband's death to recover her dower interest.

To avoid such issues, some cautious purchasers insisted that the wife join in the deed, so the absence of her signature strongly suggests her earlier death. However, you'll find many differences from one state to another. In some states such as Connecticut, until 1723, even the wife's own land that she brought to the marriage became her husband's absolutely, to sell or mortgage as he saw fit; therefore, the absence of her signature on a deed would have no genealogical significance.

Similarly, a deed from a son selling land he inherited from his father, which mentions that the land is subject to his mother's dower right, is proof that she was living at the time of the deed. But if she is not mentioned again, the genealogical significance depends on the time and place. The omission may mean only that what was left her by will was worth more and that she relinquished her dower rights. But if her husband died without a will and there is no record that she surrendered her dower rights to the son, then it's more likely she had died by the time the deed was created.

Until the enactment of married woman emancipation acts in the middle to late nineteenth century, married women were subject to the legal concept of coverture. This doctrine placed a woman under the legal umbrella of her husband. Only the husband could act for her in any legal proceeding, including selling her own land. For most married couples, only the wife's dower rights mitigated the harshness of coverture. For a more detailed discussion of this subject, please see the following links:

#### INTERMEDIATE/ADVANCED LEVEL

Coroner or Medical Examiner Records.

If you discover that the subject of your genealogical search passed away as a result of an accident, suicide, or other questionable means, you should always turn to the records maintained by the Coroner or Medical Examiner. However, deaths that fall into any type of questionable category will involve some form of

investigation by law enforcement authorities. These circumstances often are noted in most records maintained by funeral homes, cemeteries, and the death certificate generated by the County Health Department.

The Coroner or Medical Examiner will always be called on by law enforcement to determine a cause of death when suspicious circumstances arise during the investigation. These circumstances generate a paper trail. The information from the Coroner or Medical Examiner must be completed before the local law enforcement agency can complete its police report.

Information in a typical entry may include some or all of the following: name of the deceased, age, date of birth, cause of death, occupation, next of kin, witnesses to the event (if any), and other family members or acquaintances who knew the person. Though the document may contain brief details, it often provides significant information regarding family members that were interviewed or who provided information about the deceased.

Coroner or Medical Examiner records are often housed in the municipal archives of the city or in the county or state archives. You must determine whether the Coroner or Medical Examiner was in a local, county, or state position at the time of the death you are researching. The next step is to determine whether the records are in an archive or still in the city or county of original jurisdiction. Your final step involves determining what the latest guidelines are for access to the data. Some jurisdictions may limit access based on your ability to prove a direct ancestral connection to the deceased. This most likely applies to any death that has occurred within the past 50-75 years. 
